

# **TERMS OF SALE**

## ORDER ACCEPTANCE:

Terms and conditions in the price schedule constitute our entire Freight Collect, F.O.B. Covert, Michigan/shipping point. obligation on acceptance of any order. Orders subject to acceptance at the Covert, Michigan office. Prices, discounts, terms and specifications are subject to change without notice, and shall be those in effect at time of shipment.

## **PAYMENT TERMS:**

First purchase order requires payment in advance; on subsequent orders, 1% - 10 Days, net 30 Days. Interest charged on past due accounts of either 1 1/2% per month or the highest rate permitted by State law. All prices are F.O.B. Shipping Point. Catalog or quoted prices do not include sales, use, excise or similar taxes, all of which shall be paid by purchaser.

#### MINIMUM ORDER/BILLING:

\$100.00 net. Orders totaling less than \$100.00 will be assessed a \$25.00 service charge. Credit Card payments carry a 4% charge.

## **RETURN GOODS POLICY:**

No returns accepted unless authorized by the Covert, Michigan Headquarter. Any costs incurred in connection with unauthorized returns will be the responsibility of the purchaser. Return goods must be prepaid and accompanied by our Return Goods Authorization form. Any credit allowed will be subject to handling and inspection charges. There is a twenty percent restocking charge for standard products/components. No returns on custom designs.

## INTERNATIONAL SHIPMENTS

Shipping costs, including Customs and Broker Fees, special packaging for International shipments, are the responsibility of the purchaser, and will be quoted separately.

#### PREPAID FREIGHT PRICING:

Add 10% of net price or \$50 whichever is less. UPS shipments are subject to UPS shipping and handling charges.

#### SPECIAL SERVICE ORDERS:

Air Freight, Express or any other non-scheduled service will have an additional charge of \$100.

#### FREIGHT DAMAGE/SHORTAGE:

We are not responsible for products damaged while in transit. Claims for freight damage and/or shortages must be filed by the purchaser within ten days after receipt of goods. When the merchandise leaves our dock, all claims shall be made to the carrier by the purchaser; however, Swing-Lo Suspended Scaffold will assist insofar as practical in securing satisfactory adjustment of said claims. Claims are not deductable from invoices and will not be allowed.

## **APPLICABILITY**

Swing-Lo Suspended Scaffolding products are designed to perform as a complete system. Therefore, we reserve the right to refuse orders for individual components not intended for use in the complete system.

## **CATALOG**

This Price List supersedes all previous Price Lists. Swing-Lo will custom design, engineer and manufacture suspended scaffold systems to fit your specific project. All products meet or exceed OSHA standards.

## **Limited Warranty**

SWING-LO PRODUCTS are warranted to be free from defects in material and workmanship under normal use for a period of twelve months from the date of purchase. In all cases, the seller must be given a reasonable opportunity to investigate and inspect any asserted defects; and the buyer shall, at the seller's option, return any alleged defective materials to the seller's plant or authorized service depot - at the buyer's expense. Seller's liability is limited to repair or replacement of material found to be defective, free of charge, FOB plant or authorized service depot. The manufacturer reserves the right to make changes in the design or any improvements on the basic unit or any accessories at any time without incurring any obligation to install same on Swing-Lo Products or Accessories previously purchased. Any co-mingling of components not manufactured by Swing-Lo is prohibited and voids all warranties.
